

C) NEWS-ANNOUNCEMENTS ABOUT GEOGRAPHICAL INDICATIONS:

Geographical Indication and Traditional Specialty Guaranteed Emblem Regulation Entered Into Force:

Geographical Indication and Traditional Specialty Guaranteed Emblem Regulation was published in the 30285 numbered Official Gazette on 29.12.2017.

According to the regulation governing the procedures and principles for the use of emblems for geographical indications and traditional specialties guaranteed, the emblem will be used by those engaged in the production or marketing of products with registered geographical indications and traditional specialities guaranteed in accordance with the conditions laid down in the registration document.

The use of the emblem with the registered geographical indication will be mandatory. Usage of the emblem for the protection geographical indications that belong to foreign contries within the framework of bilateral or multilateral agreements is not mandatory.

The use of the registered traditional speciality guaranteed without emblem shall not be subject to the provisions of Industrial Property Law No. 6769.

The emblem shall be marked on the product or packaging together with the geographical indication or traditional speciality guaranteed in accordance with the provisions of the applicable law. If it cannot be used on the product itself or its packaging, it shall be used in such a way that it can be easily seen in the enterprise.

According to the type of the registered name, the emblems determined by the Turkish Patent and Trademark Authority shall be used and no changes shall be made on the emblem. The Regulation entered into force on 10.01.2018.

Milas Zeytinyağı was applied to EU Commission as a Protected Designation of Origin (PDO) on 13.11.2017. Bayramiç Beyazı was applied to EU Commission as a Protected Designation of Origin (PDO) on 01.02.2018. Antep Lahmacunu was applied to EU Commission as a Protected Geographical Indication (PGI) on 12.04.2018. Edremit Körfezi Çizik Zeytini was applied to EU Commission as a Protected Designation as a Protected Designation of Origin (PDO) on 26.04.2018.
